*PHEAA State Grant* – Obtain a separate summer application at [www.pheaa.org](http://www.pheaa.org) or pick up a copy at the Office of Financial Aid. Please note that students must be at least half time and are only entitled to 8 semesters of PHEAA State Grant.

*PELL Grant* – In some instances, students may be eligible for Federal PELL Grant funds for summer. The Office of Financial Aid will determine your eligibility.

*Direct Loan* – Students enrolled at least half time may borrow through the Federal Direct Loan Program; however, using Direct Loan funds during the summer will affect the amount you receive for the remainder of the academic year.

*PLUS Loan* – Parents should visit [www.washjeff.edu/loans](http://www.washjeff.edu/loans) for instruction on how to submit an application. Summer loans must be applied for separately from the academic year loans. Students must be enrolled at least half time. The only lender option for a PLUS loan is the U.S. Department of Education.

*Private Loans* – Students must submit a paper application or an on-line application. Students may have to be enrolled at least half time (refer to the requirements of the lender you choose).
